The Centers for Medicare & Medicaid Services (CMS) released regulations outlining the criteria for ACOs to participate in the Medicare Shared Savings Program (MSSP). In current Medicare ACO initiatives, beneficiaries who are Medicare-Medicaid enrollees (also known as “dual eligible beneficiaries”) may be attributed to ACOs.
